REGISTRATION PROCESS FOR SUPPLIERS - E-PROCUREMENT PLATFORM SINTEL

To properly complete the registration process, follow these two steps:

- 1. Register to the Identity Provider system of Regione Lombardia
- 2. Register to the e-Procurement platform Sintel

Important notes:

- Requests are only accepted if provided by a Legal Representative or by the Company attorneys.
- The registration process is successfully completed after the registration document produced by the platform- is received. This document must be digitally signed using a CMS Advanced Electronic Signature CAdES BES (CMS Advanced Electronic Signatures, with the encryption algorithm SHA-256, extention ".p7m"), PAdES (PDF Advanced Electronic Signature, extension ".pdf"), or others digital signatures accepted by current legislation.
- The Legal Representative is the subject in charge of the digital signature. Please visit <u>http://www.agid.gov.it/</u> for further info on digital signature.
- Sintel platform uses a certified email system called "PEC" (Posta Elettronica Certificata). A PEC address provides legal value; it is therefore highly recommended that the Legal Representative or the Company attorney provide a certified email when registering to Sintel. We invite you to consult this official list of PEC providers, provided by Agenzia per l'Italia Digitale Agency for Digital Italy (AgID) which is the technical agency of the Presidency of the Council of Ministers;

- "Username": enter an username of your choice
- "Nome": first name

Once the form is completed, the authentication system of Regione Lombardia will send you an e-mail containing a temporary password you will need to complete the first step of the registration.

To complete this first step:

- go back to homepage
- insert the Username you have chosen and the temporary password you have just received via email.

Note: You will be requested to change the password to one of your choice the first time you will access Sintel.

- Digital signature (which you must already possess).

When the procedure is completed, download the automatically generated PDF file (eg. "SupplierRegistrationRequest_000000000.pdf").

- IMPORTANT: Do not rename the PDF file;
- Apply the digital signature (the file extension will now become ".pdf.p7m") on the file and upload it back on the platform using the "Browse" button. The file must not be base-64 signed;
- Confirm the operation by clicking on the "Register" button.
- On certified email (PEC) we invite you to consult <u>this official list of PEC providers</u>, provided by Agenzia per l'Italia Digitale Agency for Digital Italy (AgID) which is the technical agency of the Presidency of the Council of Ministers;

NOTE: Once logged in the platform with your credentials, your Company has access to the main Sintel web page and you can display your Sintel status.
